I understand that there are risks to my dog, to others, and to property inherent in having my dog walked, boarded or trained by The Ruff Life Professional Dog Training (“The Ruff Life”). I also understand the special risks when my dog is walked off-leash, and playing off-leash by The Ruff Life, including but not limited to, risks presented by or to other dogs, people, cyclists, horses, motor vehicles, or any other wild or domestic animals.

I acknowledge that The Ruff Life will take such actions as are reasonable to minimize these risks but I acknowledge that it is not always possible for The Ruff Life to prevent any injuries to my dog, other people, property or animals that may occur when The Ruff Life:

- a) Walks my dog
- b) Takes my dog out for exercise, in general
- c) Trains my dog
- d) Boards my dog

I will indemnify and hold harmless The Ruff Life and its principals, partners, employees, agents and contractors (collectively the “The Ruff Life Staff”) from all alleged actions, suits, claims, costs, losses, damages, charges, and expenses whatsoever (collectively a “Claim”) for or in respect of, any direct or indirect actions of my dog whatsoever, including but not limited to loss, damage or injury to my dog, other animals, people (including without limitation The Ruff Life Staff), or property while my dog is under the care of The Ruff Life.

I warrant that my dog is suitable to be walked, trained, boarded or otherwise handled by The Ruff Life. I further warrant that my dog is not aggressive towards people or animals, and that my dog is obedient and capable of following commands from persons other than myself. I will immediately advise The Ruff Life of any problems with my dog that could affect its behaviour, health or suitability for long walks, runs, and training sessions or for any kind of exertion whatsoever. **I will be responsible financially and otherwise for all costs and damages incurred in the event that my destroys property or my dog runs away from The Ruff Life for any reason and at any time while in the care of The Ruff Life.**

Unspayed Females:

I understand that The Ruff Life shall not handle any dogs that are in heat and I will immediately advise The Ruff Life if there is any possibility that my dog may be in heat. I understand that if my dog is in heat, this could put my dog, other dogs and people, including but not limited to the dog handlers at The Ruff Life, in considerable danger while my dog is in the care of The Ruff Life. I understand that for these safety reasons, this situation must be avoided.

Unneutered Males:

I understand that there are special risks involved in having The Ruff Life take care of my unneutered male, and I agree to indemnify The Ruff Life and The Ruff Life Staff from any loss, injury or damage they may suffer as a result of my dog or any damage to me as a result thereof. This indemnity is in addition to any other indemnity found in this waiver and is not a replacement thereof.

I authorize The Ruff Life to take my dog to the nearest veterinarian considered to be the most suitable by The Ruff Life, should The Ruff Life in its sole discretion deem it advisable to take my dog to a veterinarian. I also authorize The Ruff Life and The Ruff Life Staff to administer first aid to my dog at the direction of a veterinarian. **I agree to pay for any and all veterinarian care required or advised, in the opinion of the veterinarian, and any costs associated with such care, whatever such costs may be.**

I understand that having my dog in the company of and in an environment with other dogs may involve risks regarding the contraction of illness. I agree and understand that even proper, regular vaccinations cannot guard dogs against illness and disease, and that The Ruff Life cannot in any way prevent, nor are they responsible for, any illness that my dog may contract.

I represent and warrant that my dog has received the following vaccination and booster shots as required from time to time: Canine Distemper, Para Influenza, Parvovirus, Hepatitis/Andenovirus, Corona, and Rabies.

I understand and agree that The Ruff Life cancellation policy states; any cancellation given that is not 24 hours notice, will be accounted for as a session, and will not be refunded. I also understand and agree that The Ruff Life will not provide a repayment of any money or additional services to clients who do not fulfill their training or daycare and boarding packages due to personal circumstances.
